- All bids must be accompanied by:
 - (i) A Bid Security which is clearly defined in bidding document against each item i.e., within 5% of the estimated price in the shape of CDR / Bank Guarantee in favor of PTPL.
 - (ii) Active NTN & GST Certificate of FBR or other relevant Authorities such as PRA, etc.
 - (iii) A certificate/undertaking on stamp paper of relevant value that the Bidder or its firm/company is not blacklisted by any Government or Semi-Government Department/entities (e.g. PPRA, FBR, PRA).
 - (iv) Other documentary requirements mentioned in the Bidding Documents/TORs.

INVITATION TO THE BIDDERS

1. Required Items

Punjab Thermal Power (Pvt.) Limited (PTPL) hereby initiates the procurement process in line with the provisions of Punjab Procurement Rules, 2014 (***PPRA Rules****) for item wise procurement of following personal protective equipment (PPE). The samples of the required items are available at the address given in the Bidding Document and prospective bidders are required to visit the Office and inspect the samples before submitting the bids as the items will be required as per the sample. The requisite items along with estimated prices are mentioned in the **Table 1** hereunder:

All quantities of the items are described in Table 1, whereas PTPL shall have the right, at its exclusive discretion, to increase or decrease the quantity of any or all item(s) without any change in unit price and/or other terms and conditions at the time of order placement. The detailed descriptions/specifications of the above Items are mentioned at **FORM-A**.

2. Eligible Bidders

i. Bidders who are active taxpayers and have NTN & GST certificates shall be eligible to participate in this bidding process. As a proof of being an active taxpayer, copy of Active Taxpayer List (ATL) showing name and details of the bidder must also be furnished by the bidders.

ii. Bidders should not be disqualified or blacklisted by any Government (Federal, Provincial), a local body or a public sector organization. An undertaking to this affect in form provided at Annex-D is to be provided by bidder.

3. Bid Security

Each bidder shall submit Bid Security for the item(s) for which it intends to bid, in the form of a Bank Guarantee / Call Deposit Receipt (CDR) in favor of "Punjab Thermal Power (Pvt.) Limited" as per the amount mentioned in last column of the below table. The Bid Security instrument must be submitted along with the Technical Proposal.

4. **Procurement Procedure**

- i. The procurement procedure for each Item shall be **Single Stage Two Envelope** as per Rule 38(2)(a) of the PPRA Rules. The Bid shall be a single package consisting of two separate envelopes, containing separately the Technical Proposal and the Financial Proposal. A bidder may bid for one, several or all of the Items.
- ii. Interested bidders may participate in open competitive bidding process for one, several or all items. However, the successful bidder will be selected by evaluating technical and financial bids for each Item separately.

5. Bid Submission

- i. The Technical Proposal envelope of a bidder must include one complete set of all documents required for technical evaluation of the Items he is competing for; along with duly filled Form for Technical Proposal in the prescribed format given in the bidding document, along with the Technical Conformity undertaking for each item given at **FORM-B**.
- ii. The Financial Proposal envelope of a bidder must contain duly filled Form of Financial Proposal for each Item he is competing for, in the

prescribed format given in the bidding document at FORM-C.

- iii. Envelopes are required to be clearly marked as "Technical Proposal" and "Financial Proposal" along with the name of the bidder.
- iv. Bids shall be submitted in Pak Rupees only.
- v. Bids quoted and submitted shall be inclusive of all applicable taxes and levies.
- vi. Bidders shall submit Bid in a sealed envelope on or before the closing date i.e., March 28, 2022 till 03:00 PM (Bid Submission Deadline) at the prescribed address of PTPL Head Office. Bids shall be opened publicly by PTPL after 30 minutes of the closing date and time in the presence of the Bidders or their Representatives who may choose to be present.
- vii. The bidders must provide all documents/information required under the Bidding Documents including documents mentioned in the Check List given with the Bidding Documents. The Bid Security must be placed in the envelope for Technical Proposal.

6. Bid Validity

i. Rates quoted in Bids must be valid for at least 120 days from the Bid Submission Deadline.

7. **Bid Opening**

- i. In the first instance, the "Technical Proposal" shall be opened at the given time and place in the presence of bidders or their representatives who may choose to be present. The envelopes marked as "Financial Proposals" shall be retained unopened in the custody of PTPL. PTPL shall evaluate the Technical Proposals in the manner prescribed in the bidding document, without reference to the price and shall reject any proposal which does not conform to the specified requirements.
- ii. During the technical evaluation, no amendments in the Technical Proposal shall be permitted.

8. Return of Bid Security

The Bid Security will be returned to the unsuccessful bidders after the completion of grievance period i.e., 10 Days after the uploading of Bid Evaluation Report on PPRA website.

9. Evaluation of the Bids

i. In the first instance, the "Technical Proposal" shall be opened at the given address in the presence of bidders or their representatives who wish to attend.

- ii. Bids of those bidders will be technically qualified and declared as responsive which fulfills the specifications of items and other requirements as mentioned in the bidding document.
- iii. No downward deviation will be accepted, and any such deviation will lead to disqualification/ technically non-responsiveness of the bidder.
- iv. After the evaluation of the Technical Proposals, PTPL shall invite Technically Responsive Bidder(s) to attend the opening of the Financial Proposal. The date, time, and location of the opening of Financial Proposal will be communicated by PTPL. Bidders shall be given at least one day notice of the opening of Financial Proposal.
- v. PTPL shall open the Financial Proposals of the technically responsive bids/bidders, publicly at the time, date and venue, so announced.
- vi. The lowest evaluated, technically responsive Bidder(s), on the basis of itemwise Unit Price (inclusive of applicable taxes) shall be considered as the Successful Bidder.

10. Successful Bidder

- i. Upon issuance of Purchase Order(s) by PTPL, the Successful Bidder(s) shall supply the Items as per the specifications attached with these bidding documents within provided timeframe.
- ii. The Successful Bidder(s) shall deem to warrant to PTPL that the Goods/Services supplied by the Bidder(s), under the Purchase Order are genuine, brand new, non-refurbished, un-altered in any way.

11. Performance Security

At the time of payment against Invoice, 10% amount shall be withheld as Performance Security for a period of Six (06) months and will be returned after lapse of stipulated period upon satisfactory durability of goods.

12. Delivery of the Items

- i. The Items shall be required to be provided at the office of PTPL on immediate basis after the award of Purchase Order(s) without any extra cost including transportation etc.
- ii. In case of non-delivery of Items and / or delivery not as per specifications given herein within 15 days after award of Purchase Order, the Bidder shall be entitled to forfeit the Bid Security and terminate the Purchase Order via written notice for termination of the same. However, PTPL may, in its sole discretion, extend the delivery time for reasons beyond reasonable control of successful Bidder and submission of all documents in this regard.
- iii. PTPL's representative will inspect the Items within one week of supply. Any discrepancies found during inspection must be removed within 03 working days by the successful Bidder / Supplier.

13. General Conditions

- i. The Bidder should have a registered office in Lahore at the date of submission of Bid. Sufficient local and relevant resources must also be available in the said office to cater for all the after-sales support and services.
- ii. PTPL can accept or reject all Bids at any stage as per PPRA Rules.
- iii. All Bids received late, found incomplete, unsigned, ambiguous, conditional, or over-written will not be accepted and shall be rejected.
- iv. The scope of this procurement process shall include the supply of the Items, as required and specified in FORM-A.
- v. Payments shall be made after the clearance by PTPL's representative who is responsible for inspection of the goods.
- vi. Taxes will be deducted as per applicable Government Rules / Policy.
- vii. Without prejudice to any other rights and remedies available to PTPL, the Performance Security shall be forfeited by the Purchaser, on occurrence of any/all the following conditions:
 - If the Supplier commits a default under the Purchase Order.
 - If the Supplier fails to fulfill any of the obligation under the Purchase Order or bidding documents.
 - If the Supplier violated any of the terms and conditions of the Purchase Order or Bidding Documents.
