TERMS OF REFERENCES ("TORS") FOR PROCUREMENT OF "SOFTWARE LICENSES" FOR PUNJAB THERMAL POWER (PRIVATE) LIMITED

- 1. Bidders shall be duly registered firm / company or a sole-proprietor, having valid authorization, distribution or dealership of the original manufacturer authorized to provide licenses required hereunder and support services in Pakistan. The Bidders shall provide evidence of relevant registration as applicable.
- 2. Bidders having active taxpayer registration with Tax Authorities concerned (i.e. FBR, PRA, etc.) shall be eligible to participate in this bidding process and therefore, shall submit Registration Certificate of NTN & GST/PRA.
- Only those Bidders can participate who are working as authorized partners/distributors of original manufacture(s) for the items (i.e. licenses) prescribed in Schedule-A and Bidders must attach manufacturer authority letter (MAL) or any other relevant documentary proof, to the satisfaction of the Company, otherwise, Bid(s) will not be entertained.
- 4. A certificate / undertaking, as per the undertaking form attached herewith, on a stamp paper of applicable value that the Bidder is not blacklisted by any procuring agency, federal or provincial departments, government or semi-government department, or any other authority/organization/autonomous bodies, shall also be submitted with the Bid.
- 5. The Bidder should have an office in Lahore and evidence of such office shall be submitted with Bid. Moreover, sufficient local and relevant resources shall also be available in the said office to cater for all after-sales support services.
- 6. The procurement procedure shall be **Single Stage Single Envelope** as per Punjab Procurement Rules 2014 ("**PPRA Rules**").
- 7. The Successful Bidders shall supply the items/licenses as per the requirements and specifications attached with these TORs within provided timeframe.
- **8.** No downward deviation from the required specifications of software licenses will be acceptable and the company can reject the items/ licenses found deviated downward from the specification prescribed herein.
- **9.** Rates quoted in Bids must be valid for at least 90 days from the Bid submission date.
- **10.** Bids shall be submitted in Pak Rupees only.
- 11. Bids quoted and submitted shall be inclusive of all applicable taxes and levies.
- 12. All Bids received late, found incomplete or open, or over-written will not be accepted and shall be rejected without evaluation.
- 13. The Company can accept or reject all Bids with or without assigning any reason at any stage as per PPRA Rules.
- **14.** Rates will be accepted on the basis of item wise lowest rate.

- 15. The scope of this procurement process shall include the supply of the licenses/services, configuration, installation and activation as required for proper use and as specified in Schedule-A.
- **16.** The items/licenses will be provided on immediate basis after the issuance of Purchase Order.
- 17. The successful Bidder will be responsible to supply the licenses/services, configuration and installation, complete in all aspects as per specifications provided herein and also approved by the Company.
- 18. Successful Bidder shall submit valid license certificate(s) for each item/license supplied to the Company. License certificates must be as per the specifications of items/licenses provided and verifiable from the manufacturer's resources.
- 19. Services/support shall be locally provided by the Vendor / Successful Bidder. Successful Bidder will be allowed a maximum of 04 hours' downtime for all support services.
- 20. An Authorized Representative of the Company will inspect the license certificates within one week of supply, installation and configuration. In case, any discrepancy(ies) found during inspection and trial, it must be removed within 03-working days by the Bidder/Vendor. Failing to do the same, the Company may reject the same.
- **21.** The Successful Bidder/ Vendor shall submit its Invoice upon approval/acceptance and configuration of the items supplied to the Company.
- 22. Payments shall be made after the clearance by the Company / Authorized Representative of the Company. Taxes will be deducted as per applicable laws.
- 23. At the time of payment against Invoice of each Lot/item, 10% payment shall be withheld as Performance Guarantee for Warranty Period and will be returned after lapse of warranty period.
- **24.** License period will be commenced from the date of acceptance, deployment and activation of the same, whichever later, of the relevant service(s) or license(s) to the Company.
