Punjab Thermal Power (Private) Limited (PTPL) is a private limited company, wholly owned by the Government of Punjab, Pakistan and incorporated under the Companies Act 2017. PTPL is setting up a 1263MW (Gross) Combined Cycle Power Plant near Trimmu Barrage, 23 km from Jhang city under the IPP (Independent Power Producer) regime. The plant will operate on Re-Gasified Liquefied Natural Gas (RLNG) as primary fuel and on High Speed Diesel (HSD) as a backup fuel. It has two (02) Siemens SGT5-8000H Gas Turbines, two (02) Siemens Heat Recovery Steam Generators (HRSG) and one (01) Slemens SST5-5000 Steam Turbine. For the Engineering, Procurement and Construction of the plant, China Machinery Engineering Corporation (CMEC) was awarded the EPC Contract in September 2017 after International Competitive Bidding. The project will be commissioned in phases; with both Gas Turbines (simple-cycle) reaching Commercial Operation Date (COD) during last quarter of 2018, and the whole plant (combined cycle) achieving COD in last quarter of 2019. Now PTPL intends to hire the services of a reputed engineering services firm who shall act independently and impartially in performance of tests under the Power Purchase Agreement (PPA) prior to, during and at the end of commissioning periods of the Plant.

For this purpose, PTPL invites sealed applications for prequalification of potential bidders for Engineering Services under PPA with Central Power Purchase Agency-Guarantee (CPPA-G), Pakistan of the Power Plant.
