- 6. Warranty offered if any, must be clearly mentioned on the bids. Making quality, structural material and finishing must be as per sample or specification provided in the tender documents.
- 7. Delivery Period from purchase order must be clearly specified on the bid submitted not exceeding 10 days.
- 8. Delivered Furniture will be inspected by the Assistant Manager Admin before processing of bills.
- 9. Demand Draft equivalent to Rs. 17000/- of bid value as earnest money (refundable CDR) in favor of "Punjab Thermal Power (Pvt) Ltd" should accompany the bid. Bidders with less CDR may be rejected for evaluation if objected by the tender Committee. CDR of all bidders will be retained till announcement of evaluation report and CDR of selected supplier will be retained until supplies are successfully completed & accepted.
- 10. Tenders will be opened on 06-02-2018 at 02:30 pm in the presence of bidders' representatives who choose to attend, at the address above. Late tenders will be rejected and returned unopened to the bidders.
